

## **SUMMARY ANNUAL REPORT**

### **For Five9, Inc. Health And Welfare Benefit Plan**

This is a summary of the annual report of the Five9, Inc. Health And Welfare Benefit Plan, EIN 94-3394123, Plan No. 501, for period 06/01/2024 through 12/31/2024. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Insurance Information**

The plan has contracts with The Guardian Life Insurance Company of America, Kaiser Foundation Health Plan, Inc., Vision Service Plan, Springhealth and Cigna Health and Life Insurance Company and Affiliates to pay Medical, Dental, Vision, Life Insurance, Short-term Disability, Long-term Disability, Accidental Death and Dismemberment, and Employee Assistance Program claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2024 were \$20,891,958.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2024, the premiums paid under such "experience-rated" contracts were \$14,737,019 and the total of all benefit claims paid under these contracts during the plan year was \$17,180,431.
